This Release extends to any and all claims I have, or later may have against the "**RELEASED PARTIES**" whether or not such claims result from negligence except willful neglect on the part of any or all of the "**RELEASED PARTIES**" with respect to the **EVENT(S)** or with the respect for the conditions, qualifications, instructions, rules, or procedures under which the **EVENT(S)** are conducted or from any other cause. I UNDERSTAND THAT THIS MEANS THAT I AGREE NOT TO SUE ANY OR ALL OF THE "**RELEASED PARTIES**" FOR ANY INJURY RESULTING TO MYSELF OR MY PROPERTY ARISING FROM, OR IN CONNECTION WITH SAID **EVENT(S)**.

I am experienced in and familiar with the operation of motorcycles and fully understand the risks and dangers inherent in motorcycling. I am voluntarily participating in the **EVENT(S)** and I expressly agree to assume the entire risk of any accidents or personal injury, including death, which I might sustain to my person and property as a result of my participation in the events. Whether or not such risk results from negligence (except willful neglect) on the part of any or all of the "**RELEASED PARTIES**".

WAIVER OF RIGHTS UNDER STATE STATUTES

I further agree to waive all benefits following from any state statute which would negate or limit the scope of this release and Indemnification Agreement, including but not limited to Section 1542 of the California Civil Code which provides:

"A general release does not extend to the claims which the creditor does not know or suspect to exist in his favor at the time of executing this release, which if known to him must have materially effected his settlement with the debtor."
